1. As per section 3.5.1 of the Port Melbourne Football Club Articles of Association, the Board may at its discretion in each season nominate as a person entitled to become a Life Member any person they consider to be deserving of a life membership by reason of special services rendered to the Club. The Board shall have regard to the following:
  - a) Has
    - a. Served more than 10 consecutive years on the Board; or
    - b. Contributed more than 15 consecutive years volunteer service to the Club; or
    - c. Been an adult member of the Club for at least 25 consecutive years; or
    - d. Any person who the Board considers has made a substantial contribution through the service to the Club.
  - b) Life membership will be considered for a player who plays 150 or more senior games for the Port Melbourne Football Club.

Satisfaction of the criteria listed above does not infer automatic granting of life membership. These criteria establish a minimum standard for the consideration of life membership.

In addition to the criteria listed above a nominated member must have also contributed outstanding service to the Club.

Nominations for life membership may also be made by members of the Club in writing, provided it is seconded by a Life Member
